## Connecticut Debate Association November 17, 2012 Tournament Amity High School and New Canaan High School

On behalf of Amity High School and Coach Rick Bourdeau, and New Canaan High School and Coach Kristine Goldhawk, I would like to invite you to attend our second tournament of the 2012-13 season on Saturday, November 17. We will follow our standard tournament format.

Please read the following items carefully:

1. If you plan to attend, please reply to this email or to <a href="cda">cda</a> debate@mindspring.com</a> AS SOON AS POSSIBLE with an estimate of the number of Novice and Varsity you plan to bring. Send this immediately, even if it is only a guess. We would like to have a preliminary count by Tuesday evening, November 13, so we can have the packets printed and decide how to allocate teams to the two sites.

We will try to assign you to the tournament closest to you. We have more rooms at New Canaan than at Amity. If we have a large turnout we will have to favor New Canaan. If you send in your numbers late, we may have to assign you to New Canaan.

We have space for 432 debaters and do not expect to have to limit attendance.

2. You must register your teams and judges through <u>tabroom.com</u>. Instructions for using tabroom.com for CDA can be found here: <a href="http://ctdebate.org/PDFs/Using%20Tabroom.pdf">http://ctdebate.org/PDFs/Using%20Tabroom.pdf</a>. We will be using tabroom.com for registration for all tournaments this year. The tournament will be open for registration on Monday, November 5 at 8AM, and you may enter and edit teams and judges until Friday, November 16 at 6PM.

Note we have added two groups for judges, Varsity and Novice. Please assign your experienced judges to Varsity, and your inexperienced judges to Novice. We will make adjustments to these assignments as necessary.

3. We will be using the new rules for Novice eligibility agreed at the Coaches Meeting:

The Novice division will be open to Freshman and Sophomores, regardless of experience or record. They may qualify and participate as Novices in State Finals both years. However, they may move up to Varsity at any time if they or their coach choose, and once having moved up, may not return to Novice. Coaches are encouraged to move a Novice up to Varsity as a Sophomore if they have been successful as a Freshman, but are not required to do so.

Juniors who have not debated before may participate as Novices in their first regular CDA tournament. Otherwise they may only debate in Varsity. They may not participate in State Finals except in Varsity. They may only qualify for State Finals while debating in Varsity.

Seniors may not participate as Novices in any CDA tournament.

- 4. We have changed the rules for State Finals in order to reduce the number of teams that qualify. This year, to qualify for State Finals, a debater must win a trophy at a regular tournament, or go 3-0 at two regular tournaments. In other words, simply going 3-0 at one tournament without winning a trophy will no longer qualify.
